This notification is subject to the re-appointment, if any, of eligible, existing Members of the Consumer Disputes Redressal Fora on the basis of their performance.

The eligible sitting Members of the District Fora who are seeking reappointment for another term U/s. 10(2) of the C.P. Act are also required to submit their applications in triplicate in prescribed Format-A through proper channel.

<u>Procedure for selection of candidates to the posts of Members/Lady Members of District Consumer Disputes Redressal Fora:</u>

After scrutiny of the applications received, eligible candidates will be called for WRITTEN TEST and they are required to answer the questions in English language only. The written test will be for 80 marks on Consumer related Laws such as Consumer Protection Act, Insurance Laws, Contract Law, Medical, Torts, C.P.C, Cr.P.C. Banking, Financing and General Knowledge. Interview for 20 marks. Candidates securing below 50 marks in the written test will not be considered for interview.

Call letters will be sent to the eligible candidates for the Written Test and place in advance at the appropriate time. This Commission reserves the right either to postpone or cancel this Notification or take any decision on the Notification at any point of time.

The Selection Committee on the basis of the assessment made by it, interview the three top ranking candidates satisfying the eligibility criteria, will recommend the names of the candidates for appointment as Members/ Lady Members from amongst the applicants in order of merit for consideration of the State Government for appointments.

The eligible sitting Members who are seeking for re-appointment for another term U/s 10(2) of C.P.Act need not sit for written examination. However, they are required to appear for interview whenever called for. Their merit will be assessed on the basis of their past performance simultaneously with assessment of the suitability of the candidates who will go through the process of selection under Rule 6-A of A.P. State Consumer Protection Rules, 1987.

The selected persons are liable to be posted to any of the Districts in the State. The appointment carry State-wide transfer liability.
