Terms & conditions for appointment:

- 1. Shortlisted candidates will be intially sent for six months training at any Hospital in state.
- 2. Candidates will be paid a stipend of Rs.10,000/- per month during the training perios.
- 3. After complition of six months trating candidate will have to appear for exit exam. Candidate successfully after compliting the exit exam will be apponited as Community Health Prividerat sub centres.
- 4. Candidate is expected to do home visits to atleast ten households in his/her area daily.
- 5. Candidate successfully clearing the exit exam will get a certificate which will be applicable only for working as a Community Health Provider at sub centre. This certificate does not make the candidate eligible for any specialisation/private practice.
- 6. There is no seperate provision for accommodation and other allowances during training period.
- 7. The posts are purely contractual & not state government's regular posts
- 8. During the selection process 1.5 times candidates will be selected, But after the exit exam if the number of candidates passing the examination are more than the available post then the extra candidates will be treated as waiting candidates.
- 9. Criteria for selection will bethe exam BAMS final year marks of candidates.
- Candidates holding higher qualification will be eligible for maximum of 5 additional marks (PG Diploma- 2 & PG Degree-5)
- 11. Candidates having experience of working with government/NHM/Semi government organization are eligoble 1 additional marks per year, maximum up to 5 Marks.
- 12. Candidates from the same Taluka will be given 20 additional marks. Candidates have to clearly mentioned Taluka name in there application for which he is willing to apply. (Candidates should apply only in one taluka in a particular District)
- 13. Vertical & Horizontal reservation will be applicable for appointment to Community Health Provider post and it change if eligible candidate couldn't available in given advt. Then further process will be completed as letter dated 134-138/18 05-07-2018 by Hon Commissionar/MD NHM Mumbai.
- 14. The candidates clearing exit exam will be appointed intially for 11 months, likely to be extended subject to continuation of the project from GoI. If the project is not extended" candidate cannot claim any right on the post or permanency of job protection by Government or any litigation regarding the employmant protection.

- 15. Age criteria for open category will be 38 years & for reserved categories it will be 43 years.
- 16. Age criteria will be relaxed by 5 years for existing NHM employees.
