Online test will be conducted in major cities of Andhra Pradesh & Telangana. Candidates shortlisted based on performance in Online test will be called for Certificate Verification and followed by Job Test, as applicable, which is of qualifying nature, for the candidates who found eligible at Certificate Verification. Candidates will be selected in the order of merit post wise and category wise. Candidates shall be appointed on contract/tenure basis subject to their Medical Fitness.
