- e. Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts identified for each disabilities;

Note: Definition of the above specified disabilities will be as per "THE RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016".

Only "person with benchmark disability " would be eligible for reservation with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority.

A person who wants to avail the benefit of reservation will have to submit a latest Disability Certificate, on prescribed format, issued by Medical Authority or any other notified Competent Authority (Certifying Authority) in the District of the applicant's residence as mentioned in the proof of residence in the application. The certificate should be dated on or before last of date of submission of application.

GENERAL INSTRUCTIONS:

- 1. Preference will be given to candidates having cleared JAIIB / CAIIB of Indian Institute of Banking & Finance and experience in Banking.
- 2. The qualification (Graduate / Post Graduate) shall be from a recognized university with <u>minimum 60% marks in aggregate for candidates</u>. Candidates should indicate the percentage obtained in Graduation calculated to the nearest two decimals in the application. Where **CGPA** is awarded, the same should be converted into percentage and indicated in the application. If called for interview, the candidate will have to produce a certificate issued by the appropriate authority inter alia stating the norms of the University regarding conversion of grade into percentage and the percentage of marks scored by the candidates in terms of these norms.

- 6. Reserve category candidates applying under General Vacancy will not be eligible for any concession or relaxation in any criteria- age and fee.
- 7. Minimum prescribed educational qualification & work experience for the post is prerequisite. Candidates possessing the higher educational qualification having work experience for more than the prescribed years in the relevant discipline, shall get preference.
- 8. The training period of Joint Manager, Officer Grade II, Junior Officers shall be for a period of 12 months, followed by probation period of 6 months. During the training period trainee officers will be posted at various District Co-operative Banks, Sugar Factories & Urban Co-operative Banks. Post completion of successful training candidates shall be assessed for work performance on confidential report & attendance, thereafter shall be placed on probation for 6 months at Banks Head Office / Regional Offices / Branches and upon successful completion of probation period candidates will have to clear the screening test.
