The upper age limit will be relaxable for candidates belonging to SC, ST category by 5 years and OBC category by 3 years. Candidates will be paid a consolidated remuneration of Rs.25,000/-, Rs.28,000/- and Rs.31,000/- per month for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> year of contract respectively.
- b. **Trainee Engineer-II** will be engaged initially for a period of ONE year which may be extended upto maximum of THREE years (including initial period) based on requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs.28,000/-, Rs.31,000/- and Rs. 34,000/- per month for 1st, 2nd and 3rd year of contract respectively.
