3. Quota:

Note:

- A departmental candidate who is eligible to apply for both the open and departmental quota, he/she should not submit separate application instead should select the option "BOTH" in the work experience page of the online application.
- Main written examination for departmental quota candidates is held separately.
- In case the required numbers of candidates are not available for Open sports quota, the unfilled vacancy will be filled by the Open wards quota candidates. However, the total percentage of Open Wards Quota and Open Sports quota will not exceed 20%.
- In case required numbers of candidates are not available for Wards Quota, the vacancy will be filled by the candidates of Open quota from the respective communities.
- In case required numbers of candidates are not available for Departmental quota the vacancies would be transferred to Open quota and filled on the basis of communal reservation.
- Communal reservation is provided within each quota as per existing rules.

4. PSTM preference:

At every stage of the selection, 20 % of all the vacancies will be set apart on preferential basis for the open candidates who have studied in Tamil Medium (Not applicable for Departmental Quota candidates). To avail this preference, the entire education should essentially be in Tamil medium for all the classes from 1st to 12th Std., and Bachelor's degree.

5. Age Eligibility:

The applicant should have attained the age of 20 years and should not be aged above 30 years as on 01.07.2023. The upper age limit relaxation is given to certain categories as follows: -

Backward Class (BC), Backward Class [Muslim] [BC (M)], Most Backward Class/Denotified Community (MBC/DNC).	32 years
Scheduled Caste (SC), Scheduled Caste [Arunthathiyar] [SC(A)], Scheduled Tribes (ST) and Transgenders.	35 years
Destitute Widow	37 years
Ex-servicemen/Ex-personnel of Central Armed Police Forces (Discharged from service within 3 years from the date of notification). Serving Military personnel who are going to retire within one year from the last date of receipt of online application.	47 years
Candidates applying for 20 % departmental quota	47 years

Note: The departmental candidates applying under Open Quota should satisfy all eligibility criteria prescribed for open quota.

6. **Educational Qualification:** The applicant must hold a Bachelor's Degree obtained from an Institution / University recognized by University Grants Commission / Government in 10+2+3/4/5 pattern or 10+3+2/3 pattern in case of Diploma courses. However, candidates who have obtained Bachelor's degree through Open Universities without going through above pattern will not be eligible.
7. **Communal Reservation:** Community based reservation and reservation for women will be as per existing rules. Community Certificate issued by the Government of Tamil Nadu alone will be considered for communal reservation. The details of communal reservation are given below:

Note :

- The candidate has to obtain minimum 40 marks (40%) in Tamil Language Eligibility Test, for him/her to be eligible for evaluation of his/her main examination OMR answer sheet.
- In respect of 20% Departmental candidates, the Tamil Language Eligibility Test will be commonly conducted along with those who are applying for open quota.
- The Departmental candidates who have applied under **BOTH** Open and Departmental categories should write the commonly conducted Tamil Language Eligibility Test **only once**.
- Minimum qualifying marks in Main Written Examination is 25 for open candidates and 30 for departmental candidates. However, number of candidates to be called for next stage of recruitment i.e. Certificate Verification, PMT, ET and PET are in the ratio of 1:5 of the vacancies. Similarly, the number of candidates to be called for Viva-Voce will be in the ratio of 1:2 of the vacancies.

9. **Written Examination Centre:** Examination centre will be intimated at the time of issuing Hall Ticket by TNUSRB. The Board reserves the right to increase or decrease the number of examination centres and can re-allocate the candidates to any centre on administrative grounds.
10. **Examination fee:** Applicant will have to pay examination fee of Rs.500/-. Departmental candidates appearing for both Open Quota and Departmental Quota examinations will have to pay Rs.1000/- as examination fee. The payment options are both online (Net-banking/UPI/Credit card/Debit card) and offline (State Bank of India cash challan).
11. **Online Application:** Candidates can apply online only through TNUSRB website www.tnusrb.tn.gov.in Any other mode/ form of application will be summarily rejected. Hall Tickets for Written Examinations should be downloaded by the candidates from TNUSRB website. No postal Hall Tickets will be issued.
12. **Provisional Selection:** After completion of the Viva-Voce, the candidates will be provisionally selected based on the total marks obtained by them in main written examination, PET, Viva-Voce and Special marks by following the rule of Communal and other Reservations.
13. **Medical Examination and Verification of Character and Antecedents:** The provisionally selected candidates will be subjected to Medical Examination and Verification of Character and Antecedents.
14. Additional details about recruitment process and norms for PMT, ET, PET and special marks are mentioned in the Information Brochure. Candidates can download it from the TNUSRB website www.tnusrb.tn.gov.in
